#### MACC-III Performance Locations



- Stennis Space Center is the Buying Location for the NASA Southeast Region MACC which includes:
  - Stennis Space Center (SSC), MS
  - Marshall Space Flight Center (MSFC), AL
  - Michoud Assembly Facility (MAF), LA
  - Johnson Space Center (JSC), TX
  - White Sands Test Facility (WSTF), NM
  - Kennedy Space Center (KSC), FL
- Task Orders will be issued under MACC-III for performance at these locations



#### MACC-III Scope



- Work under MACC-III is to be performed in the general construction category to include, but is not limited to, architectural, mechanical, electrical, plumbing, civil, structural, roofing, building renovations, new building construction, demolition, United States Green Building Council (USGBC) Leadership in Energy and Environmental Design (LEED) projects, and design/build projects.
- Applicable NAICS include, but are not limited to:
  - 236210 Industrial Building Construction (Anticipate MACC-III will be solicited under this NAICS)
  - 236220 Commercial and Institutional Building Construction
  - 237110 Water and Sewer Line and Related Structures Construction
  - 237990 Other Heavy and Civil Engineering Construction



### MACC-III Important Information



- Anticipate awarding up to 26 IDIQ contracts form the MACC-III solicitation consisting of:
  - Up to 24 Small Businesses to include 8(a), HUBZone, SDVOSB, WOSB,
     SB
  - Up to two (2) Unrestricted
- Anticipate minimum bonding requirements as follows:
  - SB \$10M per project, \$30M aggregate
  - LB \$100M per project, \$1B aggregate
- Anticipate Seed Projects establishing basis of price competition
- Anticipate submission of Past Performance Information



#### **MACC-III** Preparation



- Ensure System for Award Management (SAM) registration, www.sam.gov, is active, complete, and accurate (review Representations and Certifications)
- Review VETS-4212 Contractor Reporting and registration process, VETS-4212 Federal Contractor Reporting | U.S. Department of Labor
- Know your servicing Small Business Administration (SBA) Office
- Be prepared to:
  - Attend Site Visits for Seed Projects
  - Provide pricing for Seed Projects (a price will be required for each Seed Project, regardless of Seed Project location, SSC/KSC/MSFC/JSC)
  - Provide past performance / past experience for completed and ongoing contracts/projects
  - Provide documentation with your proposal to justify/verify SB status



#### MACC-III Final Thoughts



- MACC-III solicitation may be impacted by Executive Order (EO) 14275 Restoring Common Sense to Federal Procurement
  - The purpose of EO 14275 is to reform the Federal Acquisition Regulation (FAR)
  - May result in the elimination of regulations, provisions, and clauses that would otherwise be included in the solicitation
